hereby solemnly affirm on oath as under:

1. That the deponent no. 1 is a student, who has been allotted a seat by the Central Counseling Board of Uttarakhand Government, in the Shridev Suman Subharti Medical College, Dehradun for getting the studies of MBBS Course.
2. That the deponent no. 2 is the father of the deponent no. 1, who wants to get the admission of his son/daughter at the Shridev Suman Subharti Medical College, Dehradun.
3. That the Uttarakhand Government has provisionally fixed fee of the MBBS Course of the College as Rs. 5 lacs per year for the Management Quota and Rs. 4 lacs per year for the Government Quota candidates.
4. That whereas, due to disagreement with the Government regarding the fee decided by it, the College has preferred legal recourse. A Writ Petition has been filed at the Hon'ble High Court of Uttarakhand regarding the issue of Fee Fixation.
5. That the final decision regarding the fee to be payable by the candidates, shall be decided by the Appropriate Legal Authority.
6. That Shridev Suman Subharti Medical College is giving admission to the deponent no. 1, who is the son/daughter of the deponent no. 2 provisionally, on the fee decided by the Government of Uttarakhand.
7. That however, the College has informed the deponents that the final fee shall be decided by the Appropriate Legal Authority.
8. That the deponent no. 1 & deponent no. 2 have consented to abide by the decision of the Appropriate Legal Authority and shall pay the fee accordingly.

9. That the deponent no. 1 & deponent no. 2 shall be liable to pay the difference of the fee as decided by the Appropriate Legal Authority, as and when demanded by the College.
10. That in case the deponent no. 1 withdraws from the course at any stage before completion of the course, the deponent no. 1 & deponent no. 2 will be liable to pay the full course fee to Shridev Suman Subharti Medical College, Dehradun, applicable on the date of withdrawal.
11. That the above affidavit is submitted in compliance of the order of the Hon'ble High Court of Nainital, passed on 26.10.2017 in WP. No. (MS) 2389/2017.
