FEE STRUCTURE AND OTHER IMPORTANT TERMS AND
CONDITIONS FOR ADMISSION IN ACADEMIC SESSION 2017-18 IN
M.B.B.S. COURSE

Important Notes:

1. As per the judgment of the Hon'ble Supreme Court, the State Government was authorized to make an interim fee fixation committee to fix the fee till any Act is made. The State Government has enacted Ras Bihari Bose Subharti University Act in 2016 in which the right to fix fee has been given to the University. Thus, **the Ras Bihari Bose Subharti University does not come under the purview of the Fee Fixation Committee of the Government for fixation of fee.**
2. The Director General medical Education, Uttarakhand State Government has issued notification no. 3642/chi.shi./03(medical)/143/2013 dated 31.08.2017 quoting the State Government notifications no. 1075/XXVIII(1)/2013-32/2003 TC - II dated 08.05.2013, 1242/XXVIII(1)/2015-77/2013 dated 07.05.2015, through which it had fixed the fee of MBBS course of Colleges as 5 lacs for the management quota and 4 lacs for the Government quota. However, the State Government has not passed any order on the Fee Structure submitted to the Government by the College. Therefore, as a natural consequence the fee decided by the Government at present is **provisional.**
3. Presently the College will charge Rs. 5 lacs from the Management quota and 4 lacs from the Government quota candidates. **However, it may be noted that the University has proposed Rs. 18.0 lacs per year for the management quota and Rs. 13.50 lacs per year for the Government quota as the tuition fee.**
4. The State Government/Fee fixation Committee of the State Government is to oversee in due course of time that the fee decided by the University has any element of profiteering or commercialization of the education or not. In case the Government fixes some other fee for our College, unilaterally, without analyzing the Balance Sheet of the College judiciously, **the decision of the Government will be challenged at the Hon'ble High Court/appropriate legal forum.**
5. **All the students aspiring to take admission in MBBS course at Shridev Suman Subharti Medical College, Dehradun are advised to go through the following regulations very carefully-**
 - I. Full Fee (**Rs. 5 lacs for the Management quota and 4 lacs from the Government quota candidates**) is to be deposited before the **LAST DATE and Time** as mentioned in the **REPORTING MEMO** in the form of a **demand draft in the name of "Finance Controller, HNB Uttarakhand Medical Education University, Dehradun"** payable at Dehradun. No Part payment of Fee will be accepted.
 - II. Refundable security deposit will be **Rs. 2,00,000/- (Two Lacs)**, and is to be before the **LAST DATE and Time** as mentioned in the **REPORTING MEMO** in the form of a **demand draft in the name of "Dr. Jagat Narain Subharti Charitable Trust"** payable at Dehradun.
 - III. There will be **Enrollment and miscellaneous charges of Rs. 1,70,000/- each year** in addition to the Course fee which are related to the enrollment, medical examination, medical facility fee, sports fee, cultural fee, National Defense fund

contribution, examination fee, teaching manual and material fee, wi-fi fee, etc which is to be deposited before the **LAST DATE and Time** as mentioned in the **REPORTING MEMO** in the form of a **demand draft in the name of “Dr. Jagat Narain Subharti Charitable Trust”** payable at Dehradun.

- IV. Hostel & Mess charges will be as follows:
- (a) Rs. 1,50,000/- (Triple/Double Seater-Non AC) per year.
- (b) Rs. 2,00,000/- (Single Seater – Non AC) per year
- (c) Demand draft is to be made in the name of “Dr. Jagat Narain Subharti Charitable Trust” payable at Dehradun and is to be deposited before the LAST DATE and Time as mentioned in the REPORTING MEMO**
- V. If any draft has been deposited by the candidate with the DME, Uttarakhand in the head of College fee, it shall be the duty of the candidate to get the certificate from the DME that such an amount has been deposited with the DME, Uttarakhand.
- VI. No amount of more than 2 lacs will be deposited in cash in view of the Policy of the Government.
- VII. An additional tuition fee and supplementary exam’s fee from failed/detained students will be charged in subsequent years.
- VIII. The student and his/her guardian will have to give an Undertaking/Affidavit that the decision of the Hon’ble Court/Appropriate legal forum regarding the final fee will be binding upon them and they will pay the difference of the fee, if any, immediately on demand by the College. The Undertaking/Affidavit will have to be registered at the office of the Sub-Registrar by paying the requisite fee by the student.**
- IX. Hostel is compulsory for all the students except for those whose parents reside in Dehradun.
- X. Hostel fee is subject to change any time.
- XI. Fee once deposited is non-refundable.
